DOMINICA THE NATURE ISLAND

Dominica is a mountainous Caribbean island nation. This 289 square mile island is often referred to as the “NATURE ISLAND OF THE CARIBBEAN” because of its many waterfalls, hot springs, rivers and undisturbed tropical landscapes.

Dominica obtained its independence from the UK in 1978. Most of Dominica’s 72,000 inhabitants live around the capital city of Roseau. Dominica’s passport offers Visa-Free travel to over 120 countries, including the European Union (EU) States, United Kingdom, Ireland, Sweden, Switzerland, Singapore and Hong Kong.

Dominica introduced its economic citizenship program over two decades ago, which makes it one of the oldest and most reputable citizenship by investment programs in the world. Benefits of Dominica’s citizenship program include minimal taxation, residency rights and the right to dual citizenship with no residency requirement.

Dominica’s economic citizenship application process usually takes approximately 60 to 90 days from the time a complete application is submitted until clients receive the citizenship certificate and Dominica passport. The entire application process is straightforward and confidential.

LUXURY AT ITS BEST

Jungle Bay is developing 120 new luxury ecologically friendly villas to host the resort's guests. These vacation villas are for sale as real estate investments under Dominica's Citizenship by Investment Program (CIP).

The starting price for Jungle Bay vacation villas is US \$255,000 (inclusive of all closing costs, transfer taxes & deed registration). Qualified buyers are eligible for Dominica citizenship under the CIP subject to meeting the application requirements and approval. Jungle Bay will maintain the villas and market them to their guests on behalf of the owners. Villa owners and Jungle Bay will split the rental income on a 50/50 basis, net of maintenance costs.

Jungle Bay has a proven track record of operating profitably for 10 straight years, including through the difficult recession of 2008-2009. The added incentive of Dominica citizenship makes buying a Jungle Bay vacation villa one of the best real estate investments in the Caribbean.



DEVELOPMENT OVERVIEW

RESORT AMENITIES

The resort includes 120 luxury eco villas, spa, yoga centre, conference centre, restaurants & bar, swimming pools, nature trails, zipline, watersports centre, and gift shop.

DEVELOPMENT TIMELINE

US \$255,000 is the purchase price for the 1,200 square foot lot and villa. Each villa comes with its own title/deed.

- 40% Maintenance upkeep, insurance, etc.
- 30% Management, marketing, etc.
- 30% Owner rental income, equally apportioned between owners; tax free 10 years

Owners may sell their villa for a profit after three years yet still retain their Dominica citizenship and passport. The villa can be resold to another CIP applicant after five years.


